- Ensure electrical and gas safety for fixed and portable equipment.

Unit 4: Fire Safety, Emergency Preparedness, and First Aid:

- Understand fire risks in kitchen operations.
- Identify fire classes and suitable extinguishing agents.
- Install and maintain fire suppression systems.
- Conduct kitchen fire drills and evacuation procedures.

- Apply basic first aid for burns, cuts, and falls.
- Record incidents and near-misses for future risk prevention.
