- Blend Agile and Waterfall frameworks to meet compliance and adaptability demands.
- Define roles and responsibilities in a dual-governance PMO structure.
- Audit governance models with real-world PMO case studies.
- Implement change management to scale the PMO across departments.
- Benchmark against international best practices in defense and government PMOs.
