- Integrate enterprise architecture into roadmap planning.
- Define KPIs for monitoring digital strategy execution.
- Address resource planning and capability gaps.
- Ensure scalability and flexibility in the technical roadmap.

Unit 3: IT Governance Frameworks and Operating Models

- Drive continuous improvement in governance maturity.
- Build a sustainable IT governance culture.
