Introduction

- Examining market risks influencing LNG commercial decisions.

- Analyzing LNG assets including liquefaction plants and terminals.

- Reviewing LNG infrastructure requirements for global operations.
- Understanding the relationship between physical assets and commercial performance.

Unit 4: LNG Liquefaction, Shipping, and Transportation Operations
