- Identify unusual financial changes.

- Evaluate earnings quality and sustainability.

- Assess financial risks affecting decisions.

Unit 5: Financial Analysis for Decision-Making

- Link financial analysis with business decisions.
- Evaluate financial information for investment decisions.
- Assess performance before major expenditures.
- Use ratios to support resource allocation.
- Compare decisions using profitability, liquidity, and risk.
- Develop conclusions from financial analysis.
- Communicate financial findings to management.
- Use analysis for ongoing performance monitoring.
