- Calculate profitability ratios and interpret business returns.
- Interpret liquidity ratios and short-term financial strength.
- Assess efficiency using turnover and operating cycle indicators.
- Evaluate leverage and solvency to understand financial risk.
- Interpret return measures to assess resource and capital efficiency.

Unit 3: Cash Flow, Working Capital, and Earnings Quality

- Analyze operating, investing, and financing cash flows.
- Compare operating cash flow with earnings to assess cash conversion.
- Examine working capital movements and their liquidity effects.

- Evaluate receivables, inventory, and payables for performance pressures.
- Identify cash flow warning signals and financing dependence.
- Assess earnings sustainability through recurring cash generation.
- Examine free cash flow and its role in financial flexibility.

Unit 4: Comparative Analysis, Forecasting, and Financial Risk

- Compare company performance across periods and relevant benchmarks.
- Interpret trends to identify strengths, weaknesses, and financial risks.
- Analyze company performance within its industry and business model.
- Evaluate forecasts using historical results, margins, growth, and cash flows.
- Identify distortions from accounting policies and non-recurring items.
- Assess risks from leverage, liquidity pressure, and declining profitability.
- Distinguish temporary financial movements from persistent performance changes.

Unit 5: Strategic Interpretation and Business Performance Decisions

- Integrate financial findings into an overall performance assessment.
- Connect financial results with operational and strategic business drivers.
- Develop structured conclusions from financial information and performance indicators.
- Evaluate financial strengths and weaknesses for business decisions.
- Communicate financial analysis clearly to key decision-makers.
- Formulate recommendations using trends, ratios, cash flows, and performance measures.
- Prioritize findings based on materiality, impact, uncertainty, and strategic relevance.

Final Insights & Key Takeaways

Participants gain an approach to interpreting financial statements, evaluating financial performance, and identifying the drivers and risks behind business results. The course strengthens strategic financial judgment by connecting financial analysis with profitability, cash generation, operational effectiveness, risk assessment, and informed business decision-making.
