Introduction

They will evaluate working capital challenges and support financially sound business decisions.

- Evaluate working capital effects on profitability and funding.
- Recommend actions that improve liquidity and operational continuity.

- Diagnose liquidity and cash constraints.
- Interpret receivables, payables, inventory, and cash.
- Evaluate the cash conversion cycle and drivers.

- Examine supplier terms and payment timing.
- Evaluate inventory efficiency and funding implications.
- Build working capital forecasts and scenarios.
- Prioritize improvement opportunities using evidence.
- Link working capital decisions with profitability and risk.

Real-world Case Studies

- Analyze a manufacturer facing rising inventory and declining cash.
- Examine delayed collections and their effect on funding needs.
- Compare supplier payment strategies during tightening liquidity.
- Review seasonal working capital requirements in a growing distributor.
- Assess cash conversion changes after revised customer credit terms.

- Calculate DIO, DSO, and DPO.
- Interpret cash conversion cycle changes.
- Analyze working capital and liquidity ratios.
- Use trends and benchmarks to identify gaps.
- Link operational drivers to funding needs.
- Interpret turnover and liquidity indicators.
- Identify hidden working capital pressures.

Unit 3: Receivables, Inventory, and Payables Management

- Examine credit policies and collection practices.
- Analyze customer credit risk and aging.
- Evaluate inventory levels, turnover, and obsolescence.
- Assess safety stock and excess inventory.
- Examine supplier terms and payment timing.
- Balance supplier relationships with liquidity goals.
- Review overdue collections and dispute resolution.
- Assess stock rationalization and service levels.

Unit 4: Working Capital Forecasting and Financial Planning

- Develop working capital forecasts from key assumptions.
- Build rolling cash flow forecasts.
- Model seasonal, cyclical, and growth impacts.
- Assess short-term funding gaps.
- Use scenarios to test working capital changes.
- Evaluate sensitivity to financial and operational risks.
- Link forecasts to budgets and business plans.
- Compare alternative short-term funding options.

Unit 5: Strategic Optimization and Performance Governance

- Establish working capital KPIs and targets.
- Analyze root causes of cash conversion problems.
- Prioritize actions by impact, risk, and feasibility.
- Examine cross-functional working capital governance.
- Evaluate transformation and improvement initiatives.
- Develop recommendations to strengthen cash flow.
- Design reporting for trends and accountability.
- Evaluate financial, operational, customer, and supplier impacts.

Final Insights & Key Takeaways

Strategic working capital management enables organizations to improve liquidity, cash flow, operational efficiency, and profitability while balancing financial and commercial priorities. Effective decisions require continuous analysis of the cash conversion cycle, receivables, inventory, payables, forecasting assumptions, and cross-functional performance.
