- Evaluating efficiency and working capital management.
- Applying the Altman Z-Score model to identify bankruptcy probabilities.
- Designing advanced financial analysis reports using charts.
- Analyzing common-size financial statements to enhance strategic insight.
- Case studies from major companies Apple, Starbucks for practical application.

Unit 3: Evaluating Reporting Quality and Detecting Financial Manipulation

- Applying the Beneish M-Score model to detect earnings manipulation.
